Dear Artisan,

We are pleased to announce that the Wiarton & District Chamber of Commerce will be hosting a *Kris Kringle Market* in conjunction with the 2017 annual Santa Claus Parade. This is a great opportunity to introduce new items you may be launching this holiday season, expand your business, and develop new clients. The Kris Kringle Market is open to food, beverage and handmade craft vendors. The emphasis is on local Artisan vendors, therefore only Artisan vendors are eligible to participate, re-sale of mass production items and multi-level marketing businesses will not be permitted.

The *Kris Kringle Market* will be taking place in multiple locations on Berford Street in Downtown Wiarton. (Parking lots of Wiarton Service Centre, Pinkerton's Auto Supply and Penn Automotive) The registration fee of \$20 will provide the vendor with 10'X10' space, vendors are responsible to supply their own table, chairs, *tent etc. Vendors are welcome to collaborate and share a space if they wish. **Hydro services are limited and priority will be given to those requiring it for food safety measures.**
