- Accepted artwork: 2D works, sculpture, ceramics, fibre art, textiles, jewellery, woodworking, glass, photography and painting in all mediums.

Terms:

- Entry deadline is **May 25, 2020 by 6:00 pm**
- Work will be juried and successful participants will be notified by email on June. 1, 2020
- Artwork will be delivered by the artist June 9th and 10th. Between the hours of 11:00 am-6:00 pm
- Pick-up date for artwork is Tuesday August 4th. Between the hours of 9:00 am-6:00 pm
- Deep Water Gallery will process sales and pay artists by cheque within two weeks of the end of the show
- Deep Water Gallery will retain 25% of the sale price.
- No changes to title, medium or price allowed after digital submission
- Insurance for the artwork is the responsibility of the artist
- The artist gives permission to Deep Water Gallery and the Warton and District Chamber of Commerce to use images of submitted artwork in all related marketing material (including but not limited to web, internet, social media. Etc.
- Only completed applications submitted on or before the deadline will be considered. This includes application form, accompanying artist biography, electronic images of work of and
- the application fee.
- No substitutions. Only works that have been accepted by the jurors will be included in the exhibition.

- Artists may send 2 images for three-dimensional art pieces (ie. full shot and 1 detail)
